

## Rules and Regulations

- **1.** Vendors must have and provide a valid New York State Certificate of Authority.
- 2. <u>The East Avon Flea Market requires that all vendors fully cooperate and comply with the</u> <u>management of the market</u>. Customers MUST be treated with respect, courtesy, and fairness when conducting business on the premises. Failure to comply with any of the East Avon Rules and Regulations will result in immediate removal of vendor and their product!
- 3. Reserved vendor status is applicable ONLY FOR VENDORS who prepay by the month or season. Reserved spaces must be paid for the month on the first Sunday of the month, regardless of inclement weather. The rent for reserved spaces is \$140 for a four week month and \$175. for a five week month. There are to be NO EXCEPTIONS! There are NO rain dates for inclement weather. All reserved vendors MUST provide a valid New York State Certificate of Authority
- 4. Non reserved dealers pay rent at the rate of \$40. per space, per Sunday. Online prepayment for a single Sunday does NOT constitute reserved vendor status. These spaces are not reserved and there is NO GUARANTEE that you will have the same space on any given week. There are NO rain dates for inclement weather.
- **5.** Pavilion spaces (16' x 16') are available on a first come first serve basis at the rate of \$40 per space, per Sunday. Vendors must unload merchandise and be parked outside of the pavilion area by 7:30am.
- 6. There are NO rain dates for inclement weather.
- 7. Non-reserved spaces are first come, first served. Vendors may select any space within the market that does NOT have yellow spray paint on the vendor tag (yellow = reserved spot by month/season).
- 8. Vendor spaces run wooden tag to wooden tag. All vendor merchandise and vehicle(s) must fit between the two wooden tags anchored into the ground. If a vendor takes additional space next to them, they will be charged for a second space.
- 9. In most cases, vendor spaces run north and south (front/back) in the three main grassy strips of the market. This means that vendors MUST accommodate for a vendor fitting in behind them (use only half of the distance from front to back). If a vendor takes additional space behind them, they will be charged for a second space.
- 10. Vendors arriving between 7:00pm and 12:00am on a Saturday evening PRIOR to a scheduled Flea Market Sunday will be assessed a \$15.00 fee to be onsite overnight. Fee must be paid at the Vintage DriveIn ticket booth or at the concession stand inside where a receipt will be provided. Receipt must be visible on vehicle dashboard for management confirmation of payment. Note: Vendors may not set up for sales on Saturday night. They may however, select their designated space for Sunday other than those spaces which are RESERVED (yellow spray paint on tag), or will interfere with DriveIn customer parking.
- **11.** THIS IS A CARRY IN, CARRY OUT facility. Vendors may not leave trash of any kind on the premises. **There will be a \$50.00 clean-up fee assessed to any vendor in violation of this rule**. Future space assignments may be denied or terminated as a result of violation of this rule!
- 12. No food, candy, or other item may be sold for human consumption without the approval of management. *In most cases,* the vendor rate for food sales is \$100 per item, per Sunday.

## 13. Absolutely NO SALE of beverages allowed onsite.

14. No items which constitute a patent, trademark, copyright infringement, counterfeit products, nor any item involving a misrepresentation of warranty, trademark, patent, or copyright infringements of any type are allowed. If a vendor is found to be in violation of this rule, s/he will hold harmless the East Avon Flea Market from any damages, expenses, or costs which they may incur as a result of violation of this rule.

## 15. The sale of firearms is strictly prohibited.

- **16.** The sale of livestock or domestic animals is strictly forbidden.
- **17.** The sale of adult material must be completely out of sight.
- **18.** Any other item deemed hazardous to the health and/ or welfare of other persons will NOT be permitted to be sold on the premises.
- 19. MANAGEMENT IS NOT RESPONSIBLE FOR LOST, DAMAGED, OR STOLEN ARTICLES.
- **20. Absolutely no tables, merchandise, or tent structures may be left on site without prior approval from management.** Vendors may be subject to \$50.00 clean up charge for removal!!!
- **21.** If you choose to bring a pet, please clean up after it!
